Mr. Chansler,

At a special meeting on June 21, 2016 the City of Kalamazoo Tree Committee Conditionally approved your permit request amended as follows:

- The permit specifically excludes the removals requested for the Eastern half of the project. Those trees will be considered in a separate permit in 2017.
- All wood brush and debris resulting from the tree removals will be cleaned up. Wood
 will be left for a minimum of 5, maximum of 10 calendar days to allow residents who
 want the wood to take it, any remaining wood will be picked up by Consumers Energy.
 This includes the wood from the trees in the wooded area along Parkview behind the
 guardrail.
- Stumps will be Chipped a minimum of 4" below grade, excluding the stumps along Parkview/Crest where the guardrail and grade make stump removal impractical.
- Turf Damage will be restored with top dirt and seed.
- Consumers Energy must plant a total of 25, 2" Caliper trees during the first planting season after completion of construction, most likely mid April of 2017. The intent of the tree planting is to replace City Trees removed from Turf areas, additional trees will be used to fill in as space allows in curb-lawn areas along the project. The area behind the guardrail along Parkview is excluded. Trees will be planted in compliance with The City's Tree Ordinance.
- Before work begins, your contractor must provide the City with proof of insurance listing as "Also Insured, The City of Kalamazoo, its officers, agents and representatives."
